

JAEDEN SILVESTRE FOR TRUSTEE


My name is Jaeden Silvestre and I am running for the position of Trustee

Brothers and Sisters, my name is Val Stonehocker and I am running for the position of Guide.


I have been with the Union for 15 years, ten of those were spent as a Shop Steward, five as a Safety Rep and the past two as a Chief Shop Steward in Reduction.
